Delegation 9:30 a.m. Raymond J. Preteau

Ray came before council to provide information on the municipal low pressure sewer and municipal water system installed on his property at 21129 PTH 59 in St. Malo. Council would be ready to provide final approval to the water and sewer underground infrastructure on his land with the following conditions: Satisfactory inspection and approval of the septic cylinder with grinder pump from a third party, water shall be run through an appropriately sized water meter at the shop and then run to the house after the shop meter, and that a development agreement be registered on title (at the landowner's cost) to ensure that future owners are aware of the infrastructure installed there and that there would not be any possibility of subdivision unless considerable modifications of the service lines are undertaken.

Pat came to council to present a proposal for the purchase of a 1 tonne Mini Grass Fighting Pumper/Equipment/Rescue Vehicle in the approximate cost \$150,000 - \$160,000. This vehicle will replace the older Equipment Cube Van. The current pumper is in shape to last another 10 years. The Fire Chief will be approaching the Village of St. Pierre-Jolys shortly to discuss their 50% contribution to this unit.
