Raymond came before council as the Village of St. Pierre-Jolys spokesperson and St. Pierre Recreation Centre Board Member to request a contribution from the municipality to help in defraying the \$50,000 ice plant chiller repair expense they incurred last year. Ray confirms that the Village has paid for the invoice and hopes the RM is able to help share this expense.

Delegation8:30 p.m Francois Lambert, Joel Fouasse, Justin Maynard – Club Sportif de St. MaloThe Club Sportif board representatives along with 10 community supporters came to council to lobby support

for the Recreation Infrastructure Grant Program and to provide information of their May 5, 2009 Town Hall meeting that was held to obtain community support for the future Arena renovations and expansion. Their Phase 1 of their project is estimated to cost about \$750,000 for boards repairs, new dressing rooms, roof repairs and tractor room relocation.
