Martial also requests to have the municipality repair a low spot in the dyke constructed decades ago on the west side of the Rat River, south of La Rochelle near Roger Forest. A full/complete building permit will then be issued once a Construction Completion Certificate has been presented to the developer. Each building permit being approved of this partial permit will be flagged by a condition in the approving resolution and identified on the permit application form.
