"LA" Limited Agriculture Zone for the purpose of locating a 14'X24' garage (currently elsewhere on the lot) onto the existing cement pad.

The CAO reads the three written letters submitted regarding the application.

Ron and Marie Vinet – The Vinets' email correspondence confirms that they have no concerns with the Variation Orders or Conditional Uses. The request that any approval is conditional that the proposed dwelling be hooked up to the existing sewer line connected to the Village of St. Pierre-Jolys and that an engineering study, paid by the applicants, confirms that the line can accept the extra effluent, and if deemed sufficient, that the applicants negotiate with the "St. Pierre North Sewer Local Improvement District" (St. P N Sewer LID) for compensation to hook up to the existing line.

Robert Berard – Mr. Berard's email confirms that he concurs with the Vinets' email.

Remi and Irene Gregoire – The Gregoires' letter informs council that they oppose to the Conditional Use and the Variation Orders because they feel the requested setbacks to property lines does not allow for enough distance away from neighbours.

Donat Mellor – Mr. Mellor explains to council that he has concerns with the proposed new vehicular traffic that will cross his St. Pierre Car Wash's, RMB Plumbing's and Roeland's Original's properties to access the property in question. He confirms that there is a caveat registered on all affected lots to provide landlocked landowners access to their lots to the east of the St. Pierre Car Wash. He and his neighbours want to be assured that they will not be left with all the maintenance of the area where the caveat/easement agreement exists.

Robert Bruneau and Allan Roeland – The two neighbours explain to council that they have the same concerns as Mr. Mellor regarding the new vehicular traffic and the current state of the "right of way". Mr. Bruneau confirms that the right of way area is very soft in spring and many vehicles do get stuck in the frost boils. He would like to ensure that the current caveat or future one clearly details who is responsible in providing a properly maintained access to St. Pierre Lumber and Construction's property.

Jos Robidoux – As spokesperson of St. Pierre Lumber and Construction, Mr. Robidoux provides council and the audience with some clarification on the application and proposed use. The intent on having a dwelling on his property is to provide proper supervision and control to the area where there has been situations involving mischief. He acknowledges that a "multiple family dwelling" isn't a listed permitted or conditional use in a Limited Agriculture Zone and he would be open in modifying his dwelling to be a 3 bedroom single family unit. Mr. Robidoux acknowledges that he will be connecting to the area's sewer line and confirms that the St. P N Sewer LID is currently drafting an agreement regarding their investment in the sewer line.

Council will defer their decision on C2-2011-157400 and V2-2011-157400 at the next regular council meeting of March 29, 2011 at 7:30 p.m. Council requests a copy of the right of way easement agreement/caveat to determine maintenance responsibility of the right of way and a copy of the draft St. P N Sewer LID agreement to determine the sewerline responsibility.
